Official Rules for Conducting CREATIVE CHEFS SUMMIT 2017

- 1. The Event is conducted in order to develop the Ukrainian restaurant market, draw attention to restaurant franchising, exchange experience and enable communication among participants of the international restaurant franchising market.
- The Event is organised by Hoteliero LLC (hereinafter the "Organiser").
- 3. All persons who purchase a ticket to the Event consent to these Rules and assume the obligation to comply herewith. By purchasing a ticket, a visitor confirms that he/she has read and understood these Rules. When purchasing a ticket for a third party, a buyer shall familiarise a visitor with the text hereof.
- 4. A visitor of the Event may be any individual who fully and duly meets the conditions established by these Rules.
- 5. Visitors are admitted to the Event on the basis of a ticket. A ticket is valid for one person only.
- 6. At the entry to the Event, a ticket is exchanged for a bar-coded bracelet granting a visitor the right to attend the Event during the whole day of the forum (provided that the bracelet remains intact).
- 7. Tickets are checked, and visitors are admitted to the Event in accordance with the rules established by the Organiser.
- 8. Generally accepted behaviour rules and standards are in effect within the territory of the Event.
- 9. A visitor of the Event shall:
 - After a ticket is purchased, follow the official web-page of the Event at http://chefs-summit.com/ to be aware of any changes related to the Event (change of the date or time, start of individual speeches, cancellation of the Event etc.).
 - Not bring alcohol drinks, narcotic substances, weapons (including cold steel and pepperspray balls), explosives, pyrotechnical devices, lasers, lamps, flickering, glass, breakable, stabbing, cutting and other items that may damage participant and visitors of the Event.
 - Not sell, reproduce or sell a ticket to third parties.
 - Treat the Organiser, Partner, security service, service staff, participants and other visitors of the Event with respect.
 - Not sell or distribute any advertising and informational products, not conduct presentations, demonstrations, propaganda and any other advertising events and actions within the territory of the Event.
 - Not carry any property of Parkovy Convention and Exhibition Centre, Organiser, Partners, participants, visitors of the Event (including without limitation tableware, inventory and equipment) from the territory of the Event.
 - In case of emergency within the territory of the Event, strictly comply with requirements of the Organiser of the Event.
 - Not perform professional photo and video shooting within the territory of Ukraine (such shooting is possible upon the Organiser's consent only).
 - Treat property of Parkovy Convention and Exhibition Centre, Organiser, Partners, participants, visitors of the Event carefully. In case any property of Parkovy Convention

- and Exhibition Centre, Organiser, Partners, participants, visitors of the Event is damaged, compensate for inflicted damage in full.
- Immediately contact the Organiser if the ticket or bracelet is invalid, accidentally damaged, and where there are any other issues related to use of the ticket and/or bracelet.
- 10. The Organiser of the Event has the right to:
 - Deny access to or demand from the following persons to leave the territory of the event with no compensation:
 - persons under the influence of alcohol, narcotic or toxic substances;
 - persons who behave aggressively or conflict the security service, participants and visitors of the Event;
 - persons who fail to comply with safety rules (including fire safety), these Rules or who
 take actions that may damage the Organiser's reputation, Organiser's staff, participants,
 visitors and third parties.
 - Examine visitors' belongings to check for forbidden items listed in Clause 9 hereof for the purposes of safety.
 - Change the date and time of the Event.
- 11. The Organiser is not liable for health and integrity of visitors' personal belongings as well as tickets and bracelets forged by third parties.
- 12. Ticket refunding by the organizer is possible only in case of the event cancellation. Delaying the event is not areas on for ticket refund. The cost of service or other extra fees will not be refunded.
- 13. The Visitor should have ID or driving licence with you. The headset for simultaneous translation will be provided only with producing ID.
- 14. The Organiser of the Event is not liable for cancellation, change of the date and time of the Event resulting from circumstances of insuperable force beyond the Organiser's control (force majeure circumstances), including without limitation acts of God, fire, flooding, hostilities, blockade, introduction of the state of emergency or martial law, amendments to laws, resolutions of government and/or local authorities, any other circumstances beyond the Organiser's control.
- 15. In accordance with the Law of Ukraine "On Personal Data Protection", when attending the Event, visitors grant their consent to processing and use of their personal data for the purposes of the Event, namely, to collection, systematisation, accumulation, storage, specification (update, change), use, distribution, disposal of their personal data, transfer thereof to partners, contractors, business partners of the Organiser. Such consent is granted for an unlimited period of time unless it is withdrawn by a visitor on the basis of the reasonable written request. The visitor also confirms that his/her data are valid and may thereafter be processed and used by the Organiser and its partners. The visitor agrees that the Organiser is released from the obligation to notify the visitor of transfer of his/her personal data provided that such transfer meets the purposes established herein. The visitor grants his/her consent to processing of his/her personal data by the Organiser and third parties it involves.
